#### **Public Meeting Description**

The Florida Department of Transportation (FDOT), District Seven held an in-person and virtual public meeting for proposed improvements on CR 52/Meridian Avenue/21st Street/ Suwanee Way/St. Joe Road. The purpose of the meeting was to afford affected property and business owners, interested persons and organizations the opportunity to ask questions and provide comments to FDOT regarding proposed improvements.

To allow for maximum participation, the public meeting was held in two formats including at an in-person location on July 30, 2024 and virtually over the internet on July 31, 2024. Information presented was identical at all options.

The in-person meeting was facilitated by project staff. As attendees entered the meeting, they were asked to sign in and were offered a copy of the presentation and/or comment form. Members of the study team were available to answer questions and discuss the project.

The virtual online component was hosted via GoToWebinar. The online, formal presentation was given at 11 a.m. and was followed immediately by public comments. The presentation was recorded and was facilitated and moderated by a project team member who offered introductory remarks, played a presentation recording, and moderated comments.

Forty-three attendees were present at the in-person meeting and eighteen attendees joined via GoToWebinar. As part of the GoToWebinar, spoken comments were received and as well as through the chat pane.

#### **Addressed Notifications**

A notification letter was sent electronically to elected officials and appointed officials. A notification letter was mailed to property owners and tenants within the project area, inviting them to attend the public meeting. The public meeting was advertised in the Zephyrhills News, on the FDOT Public Notices website and in the Florida Administrative Register (FAR). Materials including notifications, advertisements, public notices, elected officials contact information and property owner/tenant address lists can be found in **Appendix A**.

#### **Meeting Materials**

An in-person and online presentation were developed that described the proposed changes. All participants were provided instructions on how to provide comments about the project.

Meeting materials, including exhibits, presentation slides, sign-in sheets and comment forms can be found in **Appendix B**.

#### **Attendance and Comments**

In-person attendees were able to record their comments by utilizing a written comment form. Attendees participating in the public meeting online were able to register in advance using a link that was included in the notification materials. Questions and comments regarding the proposed changes were received via GoToWebinar, chat pane. They were also received verbally, through email and a written comment form. The online GoToWebinar registration list and public questions and comments can be found in **Appendix C.** 

#### **Signage and Photos**

Directional signs assisted attendees in navigating to the in-person meeting site. A welcome sign and Title VI sign were posted near the entrance of the in-person venue. Signage and photos from the in-person public meeting can be found in **Appendix D**.





CR 52 / Meridian Avenue from 21st Street to West of 19th Street










