

## **Study Approval Notification**

On March 24, 2025 the Florida Department of Transportation (FDOT), in coordination with Pasco County, pursuant to 23 U.S.C. §327 and a Memorandum of Understanding dated May 26, 2022, and executed by the FHWA and FDOT, was granted Location and Design Concept Acceptance for the Project Development and Environment (PD&E) Study at the intersection of CR 52/Meridian Avenue/21st Street/Suwanee Way/St. Joe Road. It is located in Pasco County and is approximately 0.16 mile long.



## **Preferred Alternative**

The Preferred Alternative includes connecting CR 52/Meridian Ave., east of 21st St., to Suwanee Way/St. Joe Rd., west of 21st St. The proposed improvements will create a 4-leg intersection with CR 52/21st St. and St. Joe Rd./Suwanee Way/Meridian Ave.

The proposed improvements include two 11-foot travel lanes with turn lanes throughout the corridor. Along CR 52/21st St., from Church Ave. to Suwanee Way, the design includes a 12-foot and an 8-foot sidewalk, with a 6-foot sidewalk on the east side from Suwanee Way to Missouri Ave. On CR 52/Meridian Ave., from 21st St. to west of 17th St., the typical section includes an 8-foot sidewalk on the north side and a 6- to 12-foot sidewalk on the south side. Along St. Joe Rd./Suwanee Way, from 22nd St. to 21st St., the improvements include a 12-foot sidewalk on the south side.

## **Public Meeting Results**

The public meeting was held in-person on Tuesday, July 30, 2024, from 4:30 p.m. to 6:00 p.m. at the Pasco County Fairgrounds, 36722 CR 52, Dade City, FL 33525. A virtual public meeting via GoToWebinar was held on Wednesday, July 31, 2024, from 11:00 a.m. to 12:30 p.m. The project video was shown and an opportunity for comments and questions with the project team was provided. A total of four comments were received during the comment period: three written and one by email, all expressing general support for the project. No comments were submitted after the public meeting.

The Design, Right of way, and Construction phases are currently funded in FDOT's Five-Year Work Program (Fiscal Years 2024/2025 - 2028/2029).
