
## Interstate 75 Public Hearing

Project Development & Environment (PD&E) Studies Northern Study – from south of US 301 to north of Fletcher Avenue FDOT District 7, WPI Segment No: 419235-3, Hillsborough County Southern Study – from Moccasin Wallow Road to south of US 301 FDOT District 7, WPI Segment No: 419235-2, Hillsborough & Manatee Counties



The Florida Department of Transportation (FDOT) invites you to attend and participate in a Public Hearing regarding the Interstate 75 (1-75)improvements from Moccasin Wallow Road in Manatee County to north of Fletcher Avenue in Hillsborough County, a distance of approximately 40 miles. The hearing is being conducted to allow interested persons to comment on the conceptual design, options, and social. economic and environmental effects of the proposed improvements, and in accordance with Federal Executive Orders 11990 and 11988. The Recommended Build Alternative includes widening I-75 to the inside, with three general use lanes and three special use lanes.
