The Florida Department of Transportation (FDOT) District Seven, in coordination with Hillsborough County, invites you to attend and participate in the public hearing for the Project Development and Environment (PD&E) Studies (WPI Segment Nos. 447157-1 and 447159-1) for the proposed improvements to McIntosh Road and Branch Forbes Road, from south of US 92 to north of Interstate 4 (I-4) in Hillsborough County, a distance of approximately 1.03 miles and 0.86 miles, respectively. The proposed improvements are intended to reduce traffic congestion along with improving safety and system linkages for both Hillsborough County roadways.

The public hearing will be held Thursday, September 26, 2024, at the Hillsborough Community College, Trinkle Center, 2206 E. Cherry Street, Plant City, FL 33563.

#### What is a PD&E Study?

A PD&E Study is a comprehensive study that evaluates social, economic, and environmental effects associated with the proposed transportation improvements so that FDOT, in cooperation with Hillsborough County, can reach a decision on the type, location, and conceptual design to meet each project's proposed purpose and need. Engaging the public by sharing and receiving information is a key component of this process and is required by the National Environmental Policy Act (NEPA).

#### **Study Purpose**

The purpose of each project is to reduce traffic congestion along with improving safety and system linkage on McIntosh Road and Branch Forbes Road.

#### **Project Description**

The proposed action is to reduce traffic congestion by widening McIntosh Road and Branch Forbes Road from a 2-lane undivided roadway to a 4-lane divided roadway. Each project includes safety improvements for bicyclist and pedestrians with proposed shared-use path on both sides of the road. The proposed action will also improve system linkage to I-4 with on-ramp and off-ramp operational improvements.

#### **Existing Conditions**

McIntosh Road and Branch Forbes Road are both an existing two-lane undivided Hillsborough County roadway within the study limits. Both roadways are classified by Hillsborough County as a major urban collector with a posted speed of 40 miles per hour (mph) on McIntosh Road and 35 mph on Branch Forbes Road.

#### **Traffic and Crash Data**

Crash data along McIntosh Road and Branch Forbes Road within each of project limit was obtained from the FDOT crash records database for the 5-year period 2015 through 2019 within Hillsborough County. McIntosh Road had a total of 175 crashes reported, of which 47% rear-end type, and no pedestrian and bicycle-related crashes. Branch Forbes Road had a total of 183 crashes reported, of which 44% rear-end type, and no pedestrian and bicycle-related crashes. These segments of McIntosh Road and Branch Forbes Road each had a Historic Average Crash Rate of 10.23 and 11.10, respectively, which are greater than the Statewide Average of 0.69. If no improvements are made, these sections of McIntosh Road and Branch Forbes Road are expected to operate at LOS F by 2045. Existing annual average daily traffic (AADT) ranged from 10,000 vehicles per day (VPD) to 21,000 VPD in existing year 2020; by design year 2045, AADTs are expected to range from 16,500 VPD to 34,500 VPD within McIntosh Road and 13,500 VPD to 41,000 VPD within Branch Forbes Road study limits.

#### **Preferred Alternative**

The Preferred Alternative for each project is composed of one typical section. A major collector road with a target design speed of 35 mph is proposed for McIntosh Road and Branch Forbes Road. Each typical section has two 11-foot travel lanes in each direction, with a 22 to 64-foot raised median, along with curb and gutter. There is a 10-foot shared-use path on each side of the road. The McIntosh Road and Branch Forbes Roads typical section is attached. The McIntosh Road proposed typical section right-of-way width of 144 feet and Branch Forbes Road proposed typical section width of 150 feet. Both projects include operational improvements to I-4 on-ramps and off-ramps by adding an additional turn or auxiliary lane to all ramps.

#### **Evaluation Matrix**

An evaluation matrix comparing the No-Build and Build alternatives for each project is attached. These matrices compare preliminary cost estimates, as well as natural, physical, and social environmental factors.






