II. PROJECT BACKGROUND

SR 50 is a major east-west arterial that spans central Florida from coast to coast. In Hernando County, SR 50 connects to several regionally significant corridors, including US 19, SR 589 (Suncoast Parkway), US 41, I-75, and US 301. SR 50 is also a hurricane evacuation route, a designated truck route, part of the state's Strategic Intermodal System (SIS), and is part of the West Central Florida Metropolitan Planning Organization Chairs Coordinating Committee's (CCC) Regional Roadway Network.

In order to accommodate projected traffic increases along SR 50, the Department has initiated a study to evaluate alternative capacity and operational improvements from the Brooksville

Bypass/SR 50A/East Jefferson Street to I-75. This portion of SR 50 connects the City of Brooksville to I-75 and has been identified as a sustainable growth area in the county's comprehensive plan.

The study will evaluate the potential effects of widening SR 50 from a four-lane divided arterial to a six-lane divided arterial with operational improvements as well as the effects of incorporating multimodal improvements such as sidewalks, bicycle facilities, and transit accommodations. The length of the study is approximately 8.2 miles. It is anticipated that any improvements would be accommodated within the existing right of way with the exception of potential off-site stormwater management facilities.

III. PROJECT GOALS

The following goals and objectives have been defined for this study:

- 1. Collect necessary information to support the Department's decision on the type, design, and location of improvements within the study limits.
- 2. Evaluate alternatives based on factors related to the design and location of the facility including transportation needs, cost estimates, social impacts, economic factors, and environmental effects.
- 3. Involve and update the public on alternative development and evaluation.
- 4. Evaluate alternatives and recommend a preferred alternative.
- 5. Obtain Department and federal approval of the appropriate environmental documents.

V. IDENTIFICATION OF AFFECTED COMMUNITIES AND STAKEHOLDERS

The following techniques will be used to notify the public of the proposed transportation improvements and to solicit public input into the project development process.

A. Communities

According to the Sociocultural Data Report (SDR) generated for the project, which uses 2014 American Communities Survey 5-year estimates, the total population within the 1000-foot buffer area is 562 persons. Of the total population, 24% are included in a racial minority or ethnic minority (i.e., Hispanic or Latino of any race) category. Of the Census block groups intersecting the project buffer, three have a minority population greater than 31%, with one having greater than 84% (Table 1). In Hernando County, where the project is located, the countywide minority population percentage is 19%, lower than in the project area.

In addition to working with the media, a number of different notification techniques will be used throughout the study process. These techniques include:

Letters/Newsletters:

Invitational and informational letters and newsletter will be distributed to elected and appointed officials, property owner/tenants, business owners/operators, and interested parties as feasible. It is anticipated that three (3) newsletters will be distributed for this study: a study kick-off newsletter, a public hearing newsletter, and an LDCA acceptance newsletter. A fourth newsletter for an optional Alternatives Public Workshop will be developed and distributed at the discretion of FDOT.

Press Releases:

If required, press releases will be submitted to the FDOT seven (7) days prior to each public meeting/hearing.

Public Notices/Legal Ads:

Public advertisement will consist of a legal classified ad published in the area newspaper with the largest circulation twice prior to the public meeting/hearing, and once to announce federal Location and Design Concept Acceptance (LDCA) at the end of the study.

Public Announcements:

Information fliers will be made available to organizations such as neighborhood/civic groups, the FDOT, and Hernando County, to publish in existing newsletters and websites. Any such correspondence will be coordinated through the District's Public Information office (PIO).

Direct Mail List:

The following will be contacted by direct mail in order to obtain input throughout the study process and in order to provide study information. These groups will be notified 21 days in advance of public meetings, therefore notifications will be sent out 25 days prior to the meeting.

• Those whose property lies, in whole or in part within 300 feet on either side of the centerline for each alternative alignment as required by Section 399.155 F.S., as well as other local citizens who may be effected by the construction of this project. The property owner portion of the mailing list will be based on the county property appraiser's tax rolls.

- Local elected and appointed officials, community leaders, or individuals who have requested to be placed on the study mailing list.
- Public or private groups, organizations, agencies or businesses that have been identified or have requested to be placed on the study mailing list.

Presentations:

Presentations will be given to local officials and agencies such as the Hernando Citrus Metropolitan Planning Organization (MPO) prior to public information meetings and the public hearing to apprise local officials of the study status. Specific location and design concepts, and receive their comments.

Public Meetings:

One informal public workshop will be conducted as required by the FDOT, to present the study and the conceptual alternatives being considered and to obtain comments and input from community stakeholders and the general public.

Public Hearing:

A public hearing will be held as required by federal regulations and state law.

Informal/Unscheduled Meetings:

In addition to the scheduled public meeting(s), there may be additional meetings with the public, elected officials, public agencies or civic groups. The purpose of these meetings will be to apprise the attendees of the study status, specific location and design concepts, and to receive input.

VIII. COORDINATION WITH HERNANDO COUNTY

The following agency and public information meetings will be held to involve the public and interested agencies in the PD&E study process and to inform interested parties of the project's status.

Coordination Meetings with Local Officials

As noted in **Section V**, a kickoff letter or informative newsletter will be mailed to local, state, and federal elected officials and agencies to provide them with information about the project and to solicit their comments and support.

Meetings will be held throughout the study when deemed appreciate by the department to inform local officials of the project status, the recommended alternative concepts, and to receive their comments. Coordination will be accomplished by presentation upon request to Hernando County Board of County Commissioners, Hernando County Department of Public Works, Greater Hernando County Chamber of Commerce, Hernando County Office of Business Development, and Hernando Citrus Metropolitan Planning Organization.

Unscheduled Meetings and Presentations

The FDOT and their representative (if required) will be available with proper notice to attend meetings or make presentations. Such meetings and presentations may be held at any hour between 8:00 am and 8:00 pm on any weekday. Aerial maps, press releases, advertisements, audio/visual displays, and other materials may be used for these meetings.

X. PUBLIC HEARING

Invitations will be mailed to all property owners whose property lies, in whole or part, within at least 300 feet of the centerline of each study alternative as required by Section 339.155, F.S. and to local elected and appointed officials notifying them of the upcoming public hearing. Notices may also be hand delivered to residences and businesses/tenants located along the study corridor as deemed necessary by FDOT.

Hearing Preparation:

Slide presentations, aerial maps, graphics, and handouts will be prepared to supplement the verbal public hearing presentation.

Transcript:

A verbatim transcript of the public hearing will be compiled and will include written and verbal comments received at the hearing as well as written comments received within the established comment period after the hearing. All public hearing documentation (handouts, presentations, graphics, etc.) will be included with the public hearing scrapbook.

Documents for Public Review:

Environmental and engineering reports to support the study evaluation will be available for public review at least 21 calendar days prior to and 10 days following the public hearing date.

The transcript package will include a verbatim hearing transcript prepared by an approved court reporter, an errata sheet detailing any transcript discrepancies, a copy of all correspondence received by the Department as part of the public hearing record, and affidavits of publication for newspaper ads advertising the hearing.

Comments and Coordination Report:

A SR 50 PD&E Study Comment and Coordination Report will be produced and submitted at the conclusion of the study containing all documentation regarding public participation throughout the study period. This report shall include all comments and responses received from the public as well as Advance Notification, coordination with local officials and agencies, and public meetings, etc., the verbatim transcript from the public hearing, proof of publication, sign-in sheets, public hearing certification, and all public correspondence.

Public Hearing Scrapbook:

A scrapbook containing 11x17 reproductions of the public hearing display boards, concept plans, presentation materials, brochures, and sign-in sheets will be prepared. The scrapbook will contain information such as the total number of attendees; the alternatives that were shown; and a list of all reports that were displayed. The scrapbook cover page will include a study description, FDOT Work Program Item Segment Number (WPI Seg. No.), Federal Aid Project Number (FAP No.) if applicable, county; a study location map and the date, time, and location of the hearing. A CD containing the electronic files in .pdf format will also be included.

Study Team Debriefing:

A debriefing will be held with the study team approximately two to three weeks after the hearing (based on FDOT staff availability) to identify, review, and discuss comments and issues expressed by the public at the hearing. Questions and comments received from the public, but not answered at the hearing, will be addressed as necessary. If written response is required, the FDOT and/or their representatives will prepare

letters of response. A copy of all responses will be included in the study files and incorporated in the SR 50 PD&E Study Comments and Coordination Report.

XII. EVALUATION OF THE PUBLIC INVOLVEMENT PROGRAM

A public involvement evaluation process will be developed to assess the effectiveness of the public involvement efforts utilized throughout the study. This process will include identification of the public involvement tools, establishment of performance measures, performance evaluations and identification of improvement strategies.

XIII. PUBLIC INVOLVEMENT DURING DESIGN

It is anticipated that the Design Project Manager will maintain the appropriate level of public involvement activities throughout the final design process. These public involvement activities may include additional coordination meetings with local government and environmental permitting agencies, work sessions, and small group meetings as directed by FDOT.
