



State Road 52 New Alignment Approved

On August 28, 2015, the Florida Department of Transportation (FDOT) District Seven secretary approved the Final State Environmental Impact Report for the new alignment of State Road (SR) 52 from east of McKendree Road to east of US 301 in Pasco County, a distance of approximately 8.25 miles. The next phase of development, the design phase, or preparation of construction plans, is now underway.

Upon completion of construction, the SR 52 designation will follow new alignment from McKendree Road to Fort King Road, then along the recently improved Clinton Avenue to US 301. The existing SR 52 will then be designated a county road and will be transferred to Pasco County for ownership and maintenance purposes.

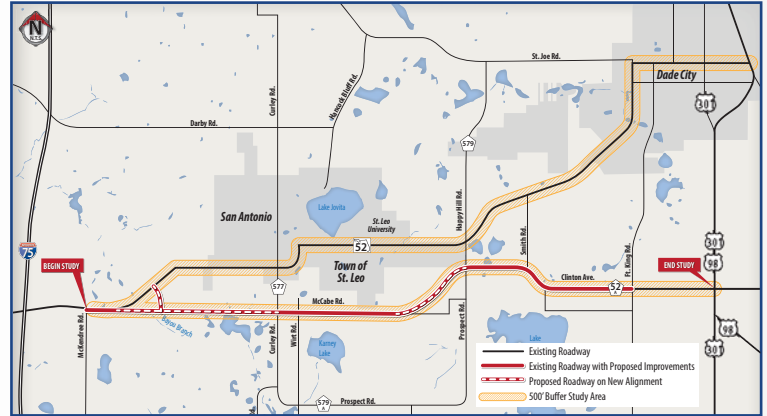
Selected Alternative

The realigned SR 52 will be a new four-lane roadway south of existing SR 52 that will serve as an additional east-west route in the regional transportation network. Pedestrian and bicycle facilities will be provided on both sides of the new roadway.

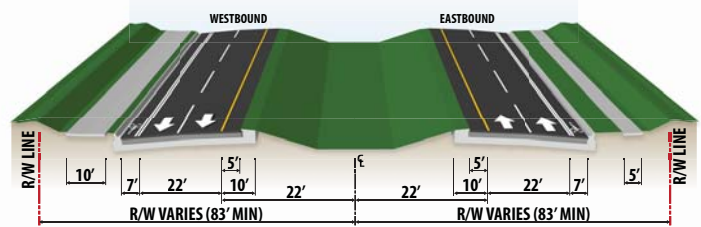
From McKendree Road to County Road (CR) 577 (Curley Road), the new SR 52 will be a four-lane suburban roadway with 11-foot travel lanes, 7-foot buffered bicycle lanes and a 44-foot depressed grass median. The roadway will be expandable to an ultimate six-lane urban roadway with a 22-foot raised median. There will be a 5-foot sidewalk on the south side and a 10-foot shared-use path on the north side. The roadway requires a minimum 166 feet of right-of-way. From CR 577 (Curley Road) to CR 579 (Prospect Road), the new roadway will be the same, except the sidewalks will be 5 feet wide on both sides.

From CR 579 (Prospect Road) to Fort King Road, the new roadway will be a four-lane urban roadway with 11-foot travel lanes, 7-foot buffered bicycle lanes, a 22-foot raised grass median and 5-foot sidewalks. This roadway requires a minimum 120 feet of right-of-way. Pasco County constructed existing Clinton Avenue from Fort King Road to US 301. It will also be designated as SR 52.

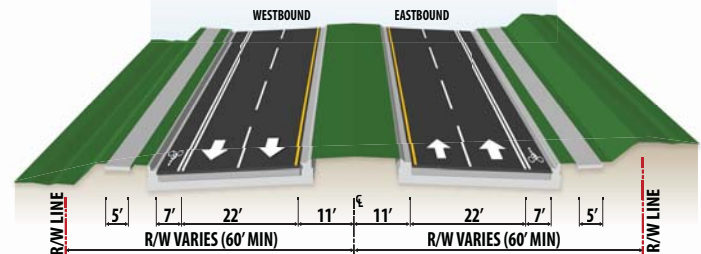
Project Location Map

From CR 579 (Prospect Road) to Fort King Road

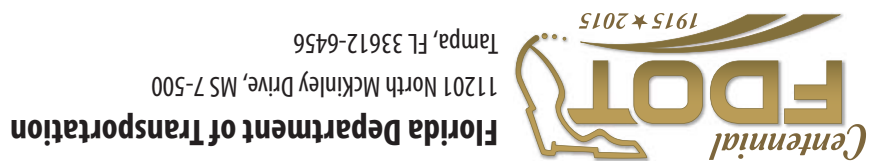
