

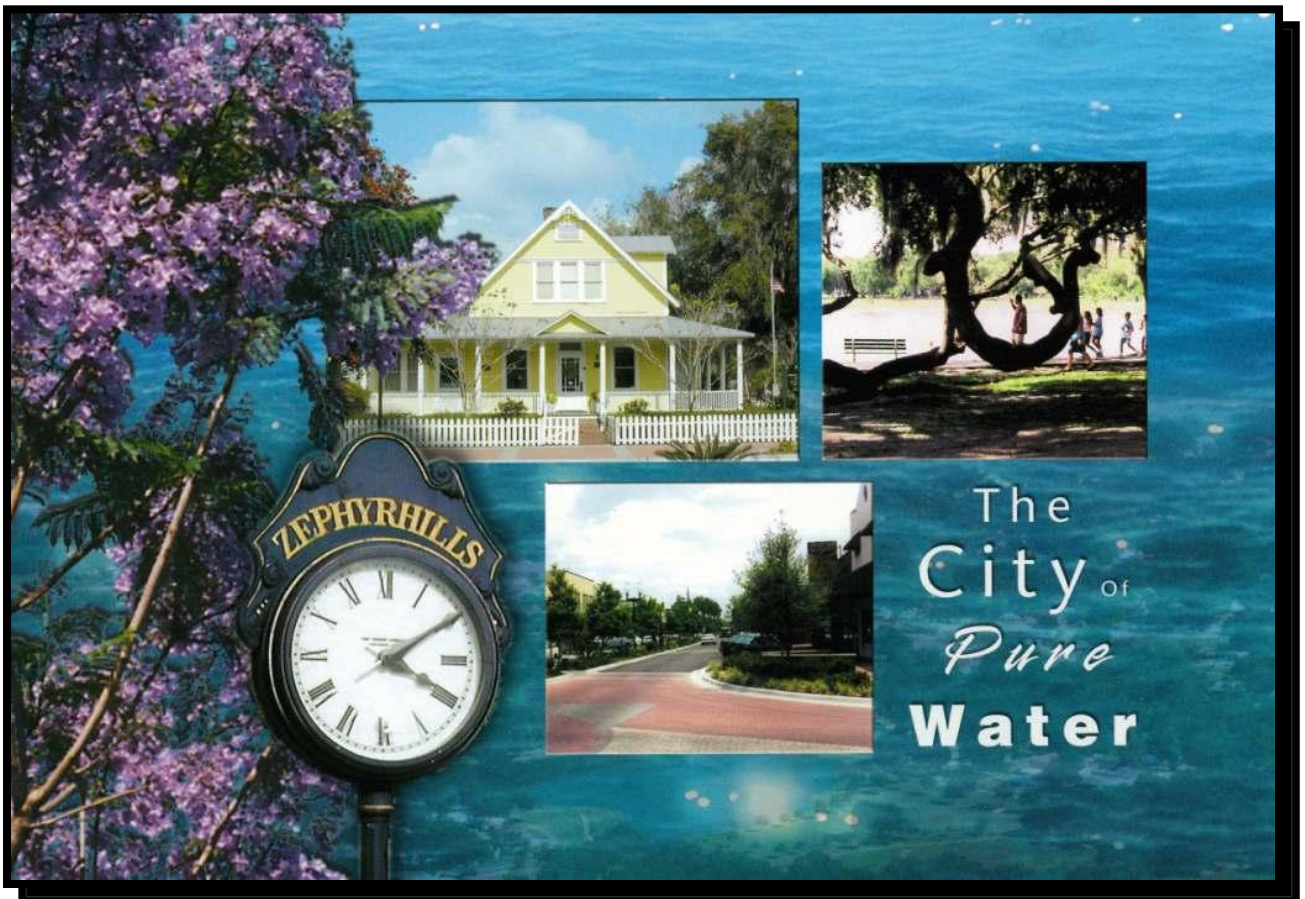

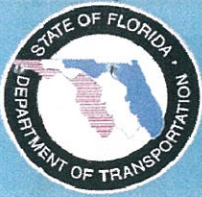

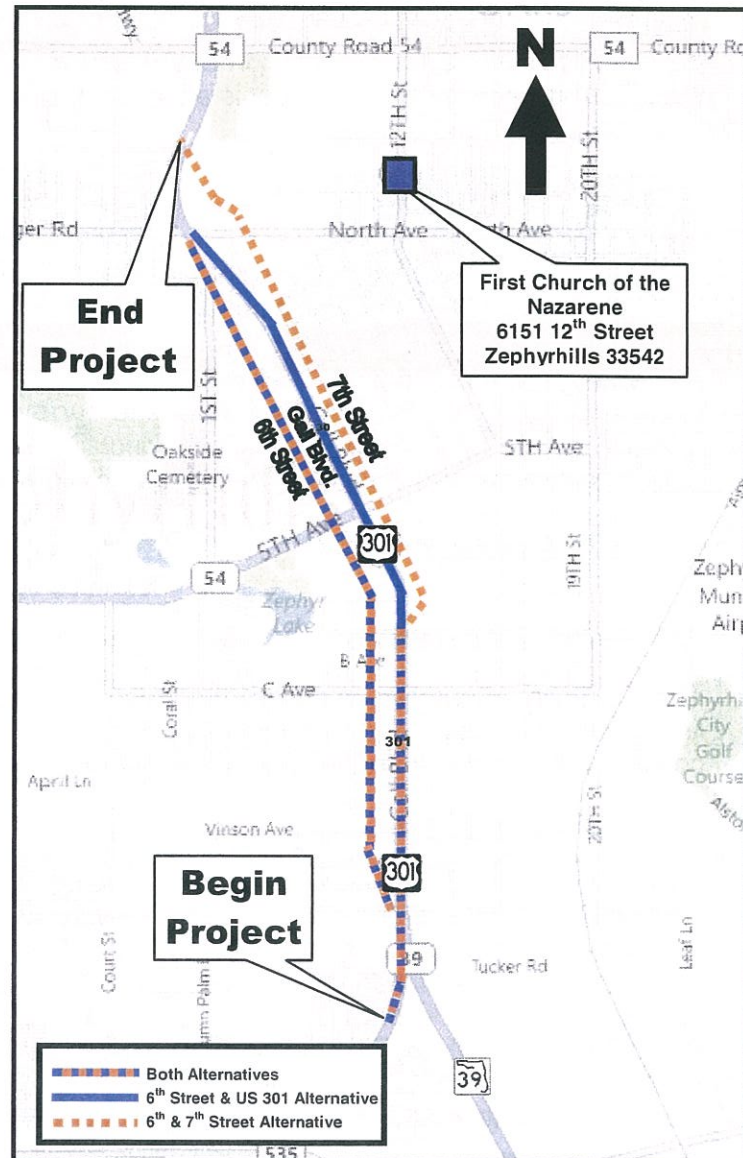

**Project Description**

The FDOT is conducting this PD&E study update to consider proposed improvements to U.S. 301/S.R. 41 locally known as Gall Boulevard. The study limits are from S.R. 39 to south of C.R. 54, a distance of approximately 2.6 miles.

The PD&E Study Update evaluates the engineering and environmental impacts of providing alternative improvements to U.S. 301. In addition to a No-Build alternative the two build alternatives under evaluation are:

**6<sup>th</sup> Street & U.S. 301 (Gall Blvd) One-Way Pair Alternative:**  
 The proposed 6th Street and U.S. 301/S.R. 41 (Gall Blvd.) One-Way Pair Alternative would convert U.S. 301 from a two-lane, two-way undivided roadway to a three-lane, one-way northbound roadway from Corey Street to Geiger Road/North Avenue. 6th Street will be converted to a three-lane, one-way southbound roadway from Corey Street to 16th Avenue. 7th Street will remain as it currently exists. The design speed is 40 mph and the anticipated posted speed is 35 mph.

**6<sup>th</sup> Street & 7<sup>th</sup> Street One-Way Pair Alternative:**  
 For the proposed 6th Street and 7th Street One-Way Pair Alternative, U.S. 301 will remain a two-lane, two-way roadway from A Avenue to North Avenue. South of A Avenue to Corey Street, U.S. 301 will be a three-lane, one-way northbound roadway connecting to 7<sup>th</sup> Street. 6th Street will be widened from a two-lane to a three-lane, one-way southbound roadway from Corey Street to 16th Avenue. 7th Street will be widened from a two-lane to a three-lane, one-way northbound roadway beginning at A Avenue and ending at the U.S. 301/Fort King Road intersection. This alternative passes through segments of the Historic District between 4<sup>th</sup> and 5<sup>th</sup> Avenue and would eliminate a number of existing nearby parking spaces. The need for improvements along U.S. 301 within the study limits was developed based on the evaluation of the following criteria:

- Existing and future quality of traffic operations along U.S. 301 assuming the existing roadway conditions;
- Traffic safety conditions for the time period between the years 2005 and 2009;



- Consistency with local government plans; and
- Projected future socioeconomic growth of Pasco County

To accommodate the expected continued growth in traffic this segment of U.S. 301 will require six travel lanes, three in each direction. The Pasco County Metropolitan Planning Organization (MPO) 2035 Long Range Transportation Plan (LRTP) identifies the conversion of U.S. 301 from an existing two-lane undivided roadway to a one-way pair system with three lanes in each direction as a cost affordable project by the year 2035.

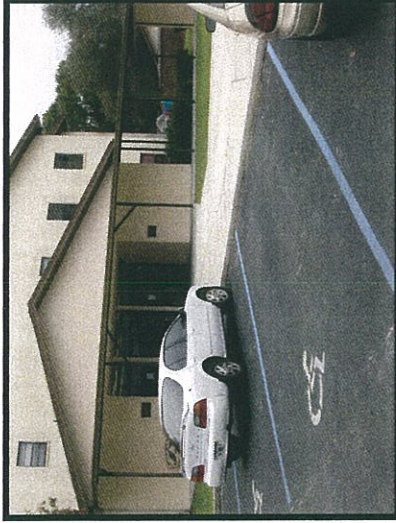

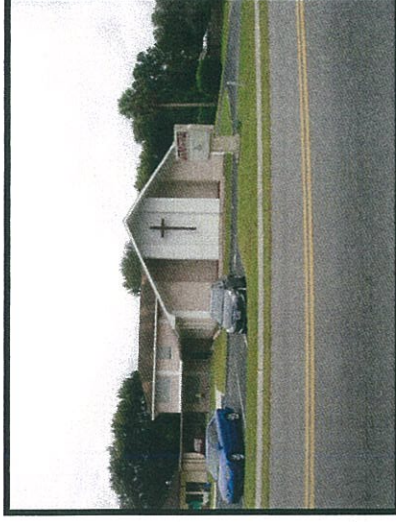

Good evening. My name is Kirk Bogen and I am the Environmental Management Office Manager for District Seven of the Florida Department of Transportation. Welcome to the Public Hearing for the U.S. 301/S.R. 41 (Gall Blvd) Project Development and Environment (PD&E) Study Update. This Public Hearing concerns the proposed roadway improvements on U.S. 301/S.R. 41 (Gall Blvd.) from S.R. 39 to south of C.R. 54 in Pasco County, WPI Segment No. 256422-2.

Both of the viable build alternatives will require the transfer of segments of existing roadway right of way for 6<sup>th</sup> Street from Pasco County and the City of Zephyrhills to the Florida Department of Transportation. The 6<sup>th</sup> Street and 7<sup>th</sup> Street alternative will require that segments of 7<sup>th</sup> Street and 5<sup>th</sup> Avenue be transferred from the

City of Zephyrhills to the Florida Department of Transportation and that segments of Gall Boulevard be transferred from the department to the City of Zephyrhills.

This Project Development and Environment, or PD&E study, and Public Hearing are being conducted under applicable Federal and State laws. Those citations are listed on the board next to the sign-in table.

You will be contacted by an appraiser who will inspect your property. We encourage you to be present during the inspection and provide information about the value of your property.

You may also be eligible for relocation advisory services and payment benefits. If you are being moved and you are unsatisfied with the department's determination of your eligibility for payment or the amount of that payment, you may appeal that determination.

You will be promptly furnished necessary forms and notified of the procedures to be followed in making that appeal.

A special word of caution - if you move before you receive notification of the relocation benefits that you might be entitled to, your benefits may be jeopardized.

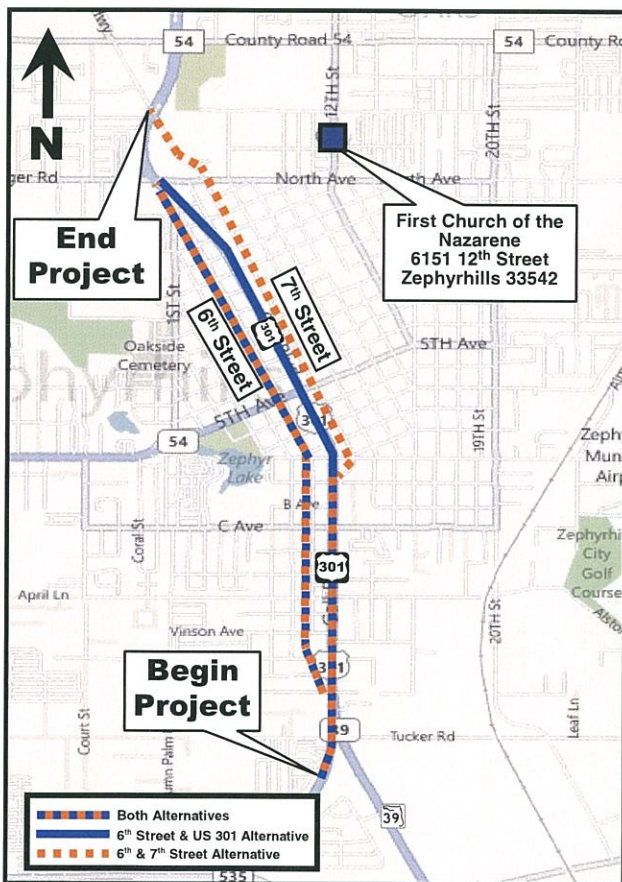
