The Department of Transportation is conducting a Project Development and Environment (PD&E) Study for US 41 (SR 45), from 12th Street to Kracker Avenue in southern Hillsborough County.



**STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION
ADVANCE NOTIFICATION FACT SHEET**

1. **NEED FOR PROJECT:** The purpose for the proposed project is to provide increased capacity and safer facility to better meet future transportation demand in this rapidly developing area of Hillsborough County. US 41/SR 45 is a major north-south urban principal arterial. US 41 runs parallel to Interstate 75 and US 301 and provides connectivity among the communities of Ruskin, Apollo Beach, Gibsonton and Riverview. While US 41 is not on the Strategic Intermodal System (SIS), a short (0.92 miles) segment of US 41 between Pembroke Road and Big Bend Road (CR 672) is part of a SIS connector, which connects the Port of Tampa to I-75, both of which are SIS facilities.

2. **DESCRIPTION OF PROJECT:** This project involves an approximately 6.2 mile segment of US 41 (SR 45) extending north from 12th Street to Kracker Avenue (**Figure 1**). The highway is to be improved from an existing four-lane divided facility to a six-lane divided facility. There are no bridge structures located on this portion of US 41.

The Build Alternative is likely to also include intersection improvements and construction of storm water management facilities. A separate traffic study will provide data to support future design alternatives and recommendations. The PD&E Study will also include the consideration of a No-Build Alternative.

As part of the Department's Efficient Transportation Decision Making (ETDM) process, a longer segment of this roadway (US 41 from 19th Avenue to Gibsonton Drive) has been screened through the Programming Screen as ETDM # 9511. A *Programming Screen Summary Report* has not yet been published.

3. ENVIRONMENTAL INFORMATION:

- a. **Land Uses:** Existing land uses include mostly agricultural, industrial, commercial, and low-density residential uses.

- b. **Wetlands:** Mangrove swamps were observed on both sides of US 41 just north of Kracker Avenue to Ohio Street. The project does not fall within an Essential Fish Habitat (EFH) assessment area. Minimal wetland impacts are anticipated by the proposed project. A Wetland Evaluation/ Biological Assessment will be conducted by the FDOT and reports will be provided to the appropriate agencies.

- c. **Floodplains:** Approximately 75 percent of the project area is located within the 100-year floodplain. These floodplains are designated as FEMA FIRM Zone AE (Special Floodplain Hazard Areas). FDOT will evaluate the need for compensation for encroachment and lost floodplain storage impacts, identify mitigation, and utilize information from existing watershed management plans. A Location Hydraulics Report (LHR) will be conducted during the PD&E phase.

- d. **Wildlife Habitat:** The entire project area is located within NOAA's Tampa Bay Estuarine Drainage Area Coastal Assessment Framework (CAF #G070) and in the Tampa Bay Ecosystem Management Area. A Wetland Evaluation/Biological Assessment will be conducted by the FDOT and reports will be provided to the appropriate agencies.

- e. **Outstanding Florida Waters:** The project area crosses a few small waterways that connect to Hillsborough Bay, including Sims Branch, Jackson Branch, Newman Branch, the Apollo Beach Canal and Wolfe Branch. There are minimal to no coastal wetlands and mangrove wetlands within the revised study limits.
- f. **Aquatic Preserve:** The project area lies within the Tampa Bay Estuary Program and is the District's top priority SWIM Program water body (Category 1 – most in need of restoration). During this PD&E Study, the FDOT will coordinate with the appropriate agencies regarding specific permitting requirements.
- g. **Coastal Zone Consistency Determination Required:** YES NO
- h. **Cultural Resources:** The project corridor has not been subjected to a Cultural Resource Assessment Survey (CRAS). During this PD&E Study, a CRAS will be conducted to determine if any sites are on or eligible for nomination to the *National Register of Historic Places*.
- i. **Coastal Barrier Resources:** No Coastal Barrier Resources are found within a 1 mile buffer of the project area.
- j. **Contamination:** There are several facilities within the 100-ft buffer that have petroleum storage tanks on-site. Two solid waste facilities are located within a 500-ft buffer but should not be impacted by this project. A Contamination Screening Evaluation Report will be prepared during the PD&E Study.
- k. **Sole Source Aquifer:** Not Applicable.
- l. **Noise Sensitive Sites:** The potential exists for increases in traffic noise to the surrounding communities. A detailed noise evaluation will be conducted during the PD&E Study.
- m. **Essential Fish Habitat:** Coordination with the National Marine Fisheries Service will be conducted during the PD&E Study, although an EFH assessment should not be necessary for this study.
- n. **Farmlands:** Although there are no Prime Farmland map units or soils within the project area, the USDA-NRCS considers any agricultural lands that produce commodity crops as Unique Farmland. Farmlands adjacent to the project will be assessed during this PD&E Study. If commodity crops (Unique Farmland) are found within the project corridor, attempts to avoid/minimize impacts to these areas will be explored.
- o. **Communities:** The project passes through both Gibsonton and Apollo Beach. The potential affect on community services and cohesion will be evaluated as part of this Study. The potential for relocation is unknown at this time. The FDOT will include public involvement opportunities throughout the Study.
- p. **Recreation Areas:** The project area is a main route for access to many recreational areas, including two public boat ramps, Big Bend Bird and Manatee Viewing Area, The Kitchen, Apollo Beach Nature Preserve, Wolf Branch, and two county preserves which currently do not have public access. No direct impacts to recreation areas are expected due to the proposed roadway project.
- q. **Wild and Scenic Rivers:** Not Applicable.

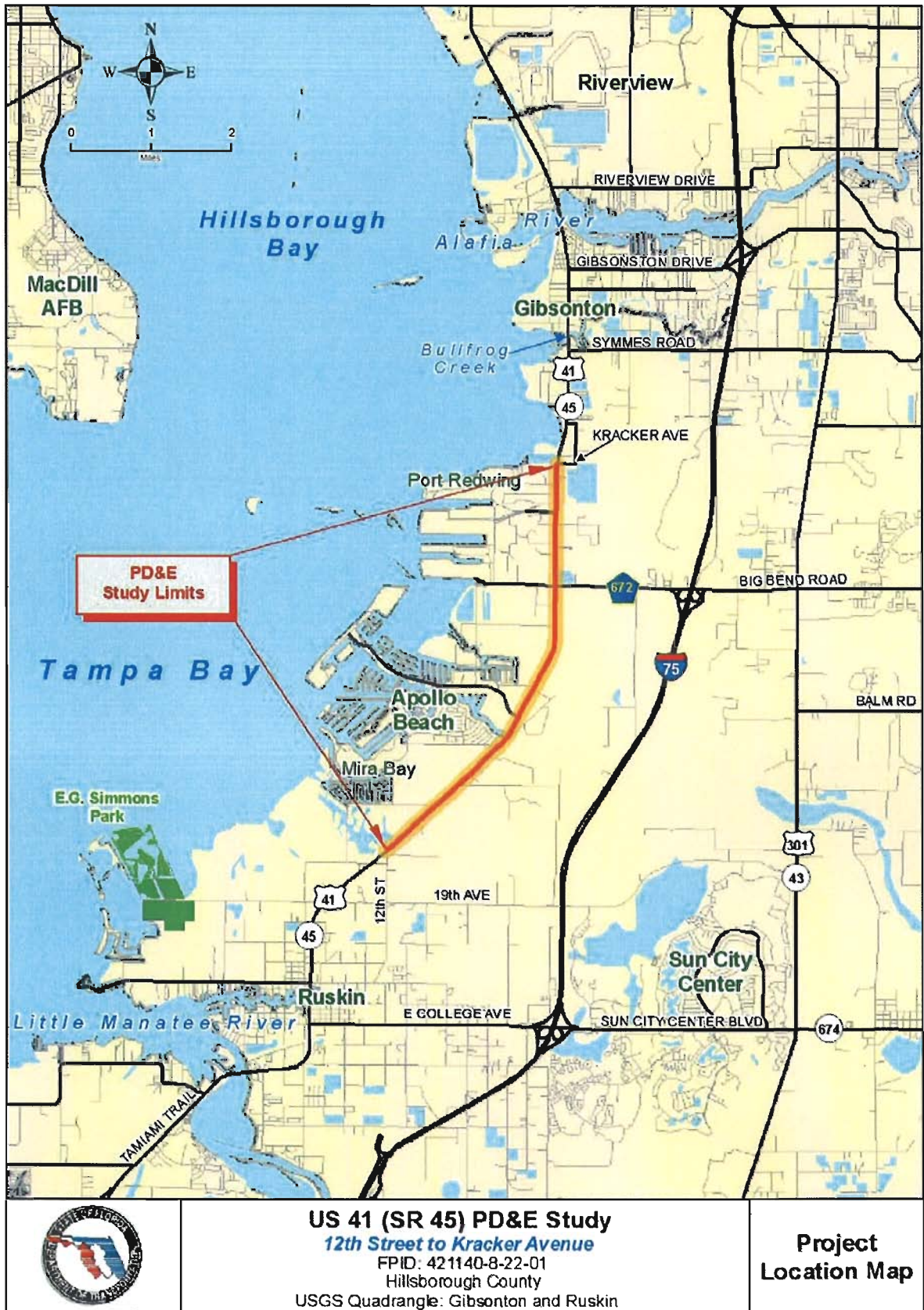




