PUBLIC INVOLVEMENT PROGRAM

Public involvement includes communicating to and receiving information from all interested persons, groups, agencies and government organizations regarding the development of a transportation project. This Public Involvement Program (PIP) documents the appropriate level of public involvement for this project in compliance with the *Florida Department of Transportation's (FDOT) Project Development and Environment (PD&E) Manual, Part 1, Chapter 11,* and *Part 2, Chapter 9;* the *FDOT Public Involvement Handbook; Section 339.155, Florida Statutes; Executive Orders 11990* and 11988; Council on Environmental Quality Regulations for Implementing the Procedural Provisions of the National Environmental Policy Act (NEPA); and 23 Code of Federal Regulations (CFR) 771. The results of the PIP will be supportive of the NEPA process and local needs.

The environmental review, consultation, and other actions required by applicable federal environmental laws for this project are being, or have been, carried out by the Florida Department of Transportation (FDOT) pursuant to 23 U.S.C. §327 and a Memorandum of Understanding dated December 14, 2016 and executed by the Federal Highway Administration and FDOT.

Activities implemented as part of this PIP will allow people living and working within the project study area, and other interested parties, to contribute to the decision-making process. The goal of the PIP is to generate interest in the project and to outline the public involvement activities planned as part of the study. This will ensure that the general public, local communities, agencies and officials, and other interested parties understand the nature of the project and its benefits by providing an open, two-way line of communication, presenting project information in an easy-to-understand format, and by making project information easily accessible. Gaining community consensus among the varied stakeholders in the study area is essential to achieving a successful project outcome. The keys to gaining community consensus are:

- Include project stakeholders early in the study process and include their input to define the conceptual alternatives;
- Develop a transparent process to screen the alternatives; and
- Maintain regular communication with project stakeholders and provide multiple opportunities
 and methods for participating in the process and providing comments, in order to shape the
 future needs and confirm the viability of the selected alternatives.

The public involvement efforts were initiated as part of the ACE study and will continue as part of the PD&E study. Public involvement efforts will seek to actively involve key stakeholders and listen to their ideas and concerns; and to document and incorporate input received during the study process. The fundamental objectives of the PIP are to ensure that the concerns and issues of those living and working within the study area, and those in close proximity who may be affected by the project, are identified; that stakeholders are given opportunities to be involved with developing the evaluation methodology and reviewing/commenting on the findings of the analysis; and that stakeholder concerns are addressed during the analysis process.

During this project development and public outreach, a global pandemic broke out that affected millions of people. In March 2020, all public involvement activities were placed on hold until the State developed a plan and response to keep Floridians safe during the COVID-19 outbreak. To protect public health and to comply with the Center for Disease Control (CDC), FDOT developed a *Guide to Hybrid Public Meetings and Hearings*. The guidance provided for continued public engagement activities using appropriate approaches evaluated on a project-by-project basis, making sure that strategies are inclusive of all affected stakeholders in a safe and social distancing manner.

II. Project Background

FDOT District 7 is conducting a PD&E study along US 98 / SR 35 / SR 700 from CR 54 to US 301 / SR 39, in Pasco County, a distance of approximately 8.5 miles. The study will focus on widening this section of US 98 from a 2-lane undivided facility to a 4-lane divided facility and includes the realignment of US 98 between CR 35A to US 301. The realignment allows US 98 to align with the Clinton Avenue (New SR 52) intersection at US 301 and was the result of a separate ACE study (WPI Segment No. 443368-1).

US 98 is a two-lane undivided facility and is functionally classified as an urban principal arterial. In addition, the project will include improvements to bicycle and pedestrian facilities. Currently, there are no pedestrian or bicycle facilities along US 98, but sidewalks on the north and south side of Clinton Avenue at the approach to the intersection with US 301. Also, bicycle lanes begin approximately 1,200 feet east of the Clinton Avenue and US 301 intersection.

The ACE study was initiated in April 2019 and approved in January 2021. The ACE identified five (5) alternative corridors for the realignment of US 98 in order to eliminate the current intersection with US 301 (SR 39) for the enhancement of safety and to provide system linkage/regional connectivity. The ACE evaluation identified Corridor B to advance to the PD&E Study for further evaluation.

The objective of the project is to develop and evaluate "Build" alternatives and provide the environmental and engineering analyses and documentation for the FDOT to reach a decision on the type, conceptual design, and location of the improvements.

III. Project Goals

The following goals have been identified for this study:

- Collect necessary information to support FDOT's decision on the type, design and location of improvements within the US 98 project limits.
- Consider community values and needs using an open decision-making process, which may accommodate community concerns, where feasible, and facilitate problem solving in a collaborative manner.
- Undertake the necessary PD&E study and documentation efforts to meet federal environmental evaluation and documentation requirements.
- Provide coordination with key stakeholders and engage the public.

The overall goal of this PIP is to help ensure that the design and the PD&E study reflect the values and needs of the communities it is designed to benefit.

IV. Identification of Agencies and Affected Public

The PIP includes conducting a formal, comprehensive community inventory to develop a stakeholder database. Public Notices/Legal Display Advertisements

Public notices will be published in the area newspaper with the largest circulation. Legal display advertisements will be published in the *Tampa Bay Times Full Edition* and/or *The Zephyrhills News* announcing the location, date, and time of the Public Hearing. All advertisements will be sent to the local newspaper via e-mail or by registered mail, return receipt requested. Public notices will also be published in the *Florida Administrative Register* and on the FDOT's *Public Notices* website at least seven (7) days prior to each public meeting. The public meetings will also be announced on the project website. A chronological file of pertinent newspaper clippings will be maintained in the project files.

Newsletters

Newsletters will be used to communicate directly with those on the project mailing list at key points throughout the study. The newsletters will contain information about the project, upcoming project activities, the current project schedule and who to contact to obtain project information.

Two (2) newsletters will be prepared for distribution to: property owners; elected and appointed officials and agencies; businesses; and other interested groups or individuals as part of the PD&E study. It is anticipated that the newsletters will be distributed for this study at the following project milestones:

Newsletters will be emailed or mailed to project stakeholders and to anyone who asks to be added to the project mailing list. They will also be made available on the project website.

Direct Mail/Email List

A mailing list will be established, and the following groups will be contacted to obtain input into the study process and/or provide project information and introduce opportunities for public comment:

- Those whose property lies, in whole or part, within the ACE study area and within 300 feet on
 either side of the centerline of each project alternative. Florida Statutes Section 339.155
 states property owners within 300 feet of the centerline of each alternative shall be notified
 about the project. The mailing list was based on information obtained from the Pasco
 Counties Property Appraiser's database.
- Elected and appointed officials in the area (city, county, state, and federal) and community leaders who have been identified or have requested to be put on the mailing list.
- Permitting agencies and other federal, state, and local agencies having jurisdiction within the project vicinity.

- Public and private groups, organizations, agencies, businesses, or individuals that have been identified or have requested to be placed on the mailing list for this project.
- Media in the project area that have been identified and placed on the mailing list to be used for news release/distribution, advertisements, or any other concerns.

Meeting Facilities Evaluation

Public meeting facilities will be convenient to the study area in locations where people normally congregate, and which are accessible to public transportation, where possible. Potential meeting sites will be visited and reviewed for suitability, including whether they are appropriate to the meeting purpose and format, and whether they comply with the requirements of the Americans with Disabilities Act (ADA) are met.

Special considerations will also be given to ensure the facilities comply with the 2005 Jessica Lunsford Act. Public school facilities, grades K-12, will not be used for public meetings while students are present. School facilities may only be used when there are no other suitable sites in the area and requires approval from the Assistant Secretary. Alternate facilities to be considered include community centers, churches, colleges, universities, and private schools.

Coordination with Local Governments

FDOT will coordinate closely local government and agency staff throughout the study process. Communication and coordination at the staff level is needed to effectively respond to the transportation needs and community concerns.

FDOT will work closely with staff from Pasco County, the City of Dade City, the City of Zephyrhills, the Pasco Metropolitan Planning Organization (MPO), and other local officials and agencies as appropriate to establish an effective line of communication to keep elected officials informed at appropriate integrals throughout the study.

Elected/Appointed Officials and Agency Kickoff Meeting

An Elected/Appointed Officials and Agency Kickoff Meeting was conducted as part of the ACE study. The Elected/Appointed Officials and Agency Kickoff Meeting was held on June 20, 2019 from 10:00 AM to 12:00 PM at the Dade City Hall Council Chambers, 38020 Meridian Avenue, Dade City, FL 33525 for elected officials, agency representatives, and other interested parties.

Public Meetings

A Public Information Meeting was conducted as part of the ACE study. The Public Information Meeting was held on November 4, 2020. The purpose of the Public Information Meeting was to present the developed corridor alternatives; share the evaluation of the developed corridors; and seek public comment on the recommendations of this analysis. Due to restrictions associated with COVID-19 safety precautions, the Public Information Meeting was conducted virtually with all information available at the project website.

Unscheduled Meetings and Presentations

In addition to scheduled meetings, participation in other meetings with the public, elected officials, special interest groups, or public agencies is expected to occur. The purpose of these meetings will be to apprise the attendees of the project status, concepts, and to receive input.

Public Hearing

In compliance with the FDOT's PD&E Manual, Part 1, Chapter 11, 23 CFR 771, and Section 339.155, FS, a Public Hearing will be held for this project. The Public Hearing will be held to involve the public, elected officials, and agencies in the PD&E Study process, to inform interested parties of the project's preferred alternative(s), and to solicit comments for the official project record.

Public hearings have evolved with innovative outreach strategies due to COVID-19. In response to public health safety protocols, FDOT developed hybrid virtual and in-person public hearings. The hybrid hearings should follow all normal approval processes while following any local ordinances concerning social distancing and capacity limitations.

Hearing attendees will have the opportunity to review and comment on project boards showing the preliminary design plans for the preferred alternative; right-of-way information; and associated reference documents. All comments received at the Public Hearing or within the comment period for the Hearing, will be part of the public record.

The hearing will be conducted at a location near the project study area and at convenient hours to accommodate and promote attendance. A quarter-page legal display advertisement will be published a minimum of 7 to 14 days prior to the hearing. Media alerts will be prepared for publication during the week of each meeting.

A newsletter and/or email announcing the Public Hearing will be sent to elected and appointed officials, agencies, property owners and interested citizens on the mailing list a minimum of 14 days prior to the hearing. Project stakeholders may also be asked to post notification of the hearing on their websites and social media pages.

Public Advertisement

Legal/display advertisements will be placed in the *Tampa Bay Times Full Edition* and/or *The Zephyrhills News*. A quarter-page display advertisement will be published twice, the first time will be 21 to 30 days prior to the Hearing, and the second advertisement will appear seven (7) to 12 days before the Hearing. In addition, the Public Hearing will also be advertised on the Project website.

Letters of Invitation

Letters of Invitation will be mailed to all property owners as required by Section 339.155, FS, and emails will be sent to local elected and appointed government officials and agency representatives notifying them of the upcoming Hearing.

<u>Virtual Attendance</u>

In accordance with FDOT Public Engagement Meeting/Hearing Guidance, the public hearings are being held in person with an option to attend virtually. Instructions will be provided in the notifications on how to access the project website, register, and participate for virtually. All comments given or submitted by the following methods are equally weighted.

- Comment during the formal portion of the public hearing (in person or virtually)
- Comment given to the court reporter at the venue

Public Hearing Follow-Up

Responses to Questions and Comments

Responses to comments and questions that need a response will be made in writing

Public Hearing Transcript Package

A Transcript Package will be produced and submitted following the Public Hearing. The Transcript Package will include a verbatim Hearing transcript prepared by an approved court reporter and an errata sheet detailing any transcript discrepancies.

Comments and Coordination Report

A Comments and Coordination Report will be produced and submitted at the conclusion of the study, in a bound booklet with a cover, containing, at a minimum, all documentation regarding public participation performed throughout the study period. This report shall include a summary of all comments and responses received from the public, as well as records of coordination with local officials and agencies, and public meetings; the verbatim transcript from the Public Hearing; proof of publication of legal ads; Public Hearing certification; newsletters; sign-in sheets; comment forms; and all public correspondence. The Comments and Coordination Report will be submitted with the final engineering and environmental documents. A summary of the public involvement efforts shall be included with the final engineering document.

VI. Title VI of the Civil Rights Act of 1964 and related statutes

In accordance with Title VI of the Civil Rights Act of 1964, all reasonable steps will be taken to ensure that persons with limited English proficiency receive the "language assistance necessary to afford them meaningful access to programs and services".
